District 21 President of the Year. Recognition of outstanding achievement of a member serving as Club President who brings value to the club, and models commitment to all members.

President of the Year is awarded at the Division and District level only. The award recognizes exceptional leadership while serving as a Club President

Eligible clubs will be notified by the District each year, and those clubs should complete the nomination form and submit it to their Division Director by September 15 each year. Eligibility requirements are listed in the District Procedures document, and (in brief) are:

1. Achieve a Distinguished Club recognition
2. Submit semi-annual reports at World Headquarter by October 1 and April 1
3. Submit new club officer list by June 30 at end of term of office as President
4. The club is represented (in person, or by proxy) at each of the District Fall Conference and Spring Convention
5. The club is represented (in person, or by proxy) at the Toastmasters International Convention Annual Business meeting
6. For clubs that elect annually, the President is not serving a successive full term in office
7. For clubs that elect semi-annually, the President is not serving a second or more successive term in office

The following criteria are considered to be key areas of effectiveness in which a Club President should excel:
